The programs have been granted accreditation for 3 years. **SNJB's Shri Hiralal Hastimal (Jain Brothers, Jalgaon) Polytechnic, Neminagar A/P: Chandwad, Tal: Chandwad, Dist.: Nashik-423101, Maharashtra-423101** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **SNJB's Shri Hiralal Hastimal (Jain Brothers, Jalgaon) Polytechnic, Neminagar A/P: Chandwad, Tal: Chandwad, Dist.: Nashik-423101, Maharashtra-423101** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
